

Privacy and Cookie policy

BusinessAndAngels.eu is committed to protecting and respecting your privacy. This privacy Policy applies to the website BusinessAndAngels.eu, owned and operated by INMUNE MARKETING, S.L. This privacy Policy describes how BusinessAndAngels.eu collects and uses the personal information you provide on the Site. It also describes the choices available to you regarding our use of your personal information and how you can access and update this information.



Business and Angels

Information we may collect from you

We may collect and process the following data about you, provided at the time of requesting Services or information from us:

- Information that you provide to us by filling in forms on our Site may include Contact Information such as name, email address, mailing address, phone number, Financial Information such as bank or brokerage account numbers, Unique Identifiers such as user name, account number, password, and Preferences Information such as favourite's lists, transaction history, marketing preferences or the like. If you chose to list your StartUp with us, we may ask for Information about your business such as StartUp name, StartUp size, business type and personal information such as a professional profile.
- Information that you provide to us when you write to us (including by email).
- Information that you provide to us when we speak to you by telephone. We may make and keep a record of the information you share with us.
- Information that you provide to us by completing surveys.
- Information obtained by us from third parties in accordance with this Privacy and Cookie Policy.

As is true of most web sites, we gather certain information automatically and store it in log files. This information includes internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, and clickstream data. We use this information to analyze trends, to administer the site, to track Users' movements around the site and to gather demographic information about our user base as a whole.

Uses made of the information

We use information held about you in the following ways:

- To ensure that content from our Site is presented in the most effective manner for you and for your computer.
- To provide you with information or Services that you request from us, where you have consented to be contacted for such purposes.
- To carry out our obligations arising from any contracts entered into between you and us.
- To notify you about changes to our Services.

We may also use your data, and/or permit selected third parties to use your data, to provide you with information about goods and services which may be of interest to you and we and/or they may contact you about these. We and/or any third party that we permit to use your data will not contact you by electronic means to provide you with information about goods and services which may be of interest to you, unless you have consented to this. Disclosure of your information

We will share your personal information with third parties only in the ways that are described in this Privacy and Cookie Policy. We do not sell your personal information to third parties.

We may disclose your personal information to any member of our group, which means our subsidiaries, our ultimate holding StartUp and its subsidiaries or the WELCOME Consortium.

In addition to the above, we may disclose your personal information to third parties:

- In the event that we sell or buy any business or assets, in which case we may disclose your personal data to the prospective seller or buyer of such business or assets. You will be notified via email and/or prominent notice on our Web site of any change in ownership or uses of your personal information, as well as any choices you may have regarding your personal information.
- If INMUNE MARKETING, S.L. or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our Terms and Conditions of Website Use and other agreements; or to protect the rights, property, or safety of us, our customers, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection and credit risk reduction.
- If you have applied to invest in a StartUp via our Site, your personal information may be disclosed to the StartUp (or the StartUp's representatives) that you have applied to invest in.

We may provide your personal information to companies that provide services to help us with our activities, such as offering customer services or to improve our operations. These companies are authorized to use your personal information only as necessary to provide these services to us.

We do not disclose information about identifiable individuals to our advertisers, but we may provide them with aggregate information about our Users. We may also use such aggregate information to help advertisers reach the kind of audience they want to target. We may make use of the personal data we have collected from you to enable us to comply with our advertisers' wishes by displaying their advertisements to that target audience.

Access to Information

If your personal information changes, or if you no longer desire our service, you may correct, update, amend, delete/remove or request it be deleted by making the changes in your User account settings page or by emailing our Customer Support at support@BusinessAndAngels.eu or by contacting us by telephone or postal mail at the contact information listed below. We will respond to your request to access within 30 days.

We will retain your information for as long as your account is active or as needed to provide you services. We will retain and use your information as necessary to comply with our legal obligations, resolve disputes and enforce our agreements.

If you wish to subscribe to our newsletter(s), we will use your name and email address to send the newsletter to you. Out of respect for your privacy, you may choose to stop receiving our newsletter or marketing emails by following the unsubscribe instructions included in these emails, accessing the email preferences in your account settings page or you can contact us at support@BusinessAndAngels.eu

Similarly, you have the right to ask us not to process your personal data for marketing purposes. We will usually inform you (before collecting your data) if we intend to use your data for such purposes, or if we intend to disclose your information to any third party for such purposes. You can exercise your right to prevent such processing by contacting us at any time.

Cookies and Tracking Technologies

Technologies such as: cookies, beacons, tags and scripts are used by BusinessAndAngels.eu and our partners, including marketing partner affiliates, or analytics service providers and business process service providers. These technologies are used in analyzing trends, administering the site, tracking Users' movements around the site and to gather demographic information about our user base as a whole. We may receive reports based on the use of these technologies by these companies on an individual as well as aggregated basis.

We use cookies to estimate our audience size and usage pattern; to store information about your preferences, and so allow us to customize our Site according to your individual interests; to speed up your searches; and to recognize you when you return to our Site. Users can control the use of cookies at the individual browser level. If you reject cookies, you may still use our site, but your ability to use some features or areas of our Site may be limited.

We may partner with third party Ad Networks to either display advertising on our Web site or to manage our advertising on other sites. Our Ad Network partners may use cookies and Web beacons to collect non-personal information about your activities on this and other Web sites to provide you targeted advertising based upon your interests. If you wish to not have this information used for the purpose of serving you targeted ads, you may opt-out by e-mailing us to support@BusinessAndAngels.eu Please note this does not opt you out of being served advertising. You will continue to receive generic ads.

How we store, process and secure our personal data
